About the registration process

The length of the registration process varies depending on several factors such as:

- The time of year (all processes are likely to take longer over the period from mid-December to late February).
- Recent changes that may be in the process of implementation and therefore take longer than necessary.
- The responsiveness of individual candidates and their ability to process application forms quickly.

However, we find that most candidates can complete the entire process within 6 to 9 months. For those who are onshore for part or all the process, the process may be shorter by several weeks.
